13 WHEREAS, It is the policy of the Board of Supervisors that each program of the City  
14 and County of San Francisco be the subject of a performance audit at least once every eight  
15 years; and

16 WHEREAS, The function of regular performance audits is to ensure that City  
17 departments and agencies make prudent and efficient use of City resources and also  
18 effectively perform the functions assigned to them by the Charter and applicable laws; and  
19 now be it;

20 MOVED, That the Budget and Legislative Analyst is hereby directed as a first priority to  
21 conduct a performance audit of the Fire Department's allocation of resources to emergency  
22 medical services; and

23 MOVED, That the Budget and Legislative Analyst is hereby directed as a second  
24 priority to conduct a performance audit of Fire Department's administrative staffing and  
25 strategic planning; and, be it

1           FURTHER MOVED, That the performance audit of the Department of Public Health's  
2 compliance with privacy and security regulations as defined by the Health Information  
3 Technology for Economic and Clinical Health (HITECH) Act and Health Insurance Portability  
4 and Accountability Act (HIPAA), previously approved by the Board of Supervisors (Motion 13-  
5 084) is removed from the Budget and Legislative Analyst's Audit Plan.
