2 **Motion supporting an amendment to the San Francisco Municipal Transportation**  
3 **Agency's FY2015-2016 Operating Budget to provide free Muni service to low and**  
4 **moderate income 19 to 22 year-old students enrolled in the San Francisco Unified**  
5 **School District's Special Education Services Program, and affirming the Municipal**  
6 **Transportation Agency's determination under the California Environmental Quality Act.**

8 WHEREAS, On August 19, 2014, the San Francisco Municipal Transportation Agency  
9 (SFMTA) Board of Directors adopted Resolution No. 14-133, approving Free Muni service for  
10 low and moderate income 19 to 22 year old San Francisco Unified School District (SFUSD)  
11 students enrolled in the SFUSD's Special Education Services program and urging the Board  
12 of Supervisors to approve the fare change for FY2015-2016; and

13 WHEREAS, A copy of the said Resolution is on file with the Clerk of the Board of  
14 Supervisors in File No. 140911; and

15 WHEREAS, Pursuant to the Charter, Section 16.112, advertisements were placed in  
16 the City's official newspaper, the San Francisco Chronicle, to provide published notice of the  
17 August 19, 2014, hearing which ran for five consecutive days beginning on July 26, 2014; and

18 WHEREAS, SFMTA staff, under authority delegated by the Planning Department,  
19 determined that the proposed program is statutorily exempt from environmental review  
20 pursuant to California Public Resources Code, Section 21080(b)(8) and CEQA implementing  
21 guidelines. Said determination is on file with the Clerk of the Board of Supervisors in File No.  
22 140911 and is incorporated herein by reference. The Board affirms this determination. The  
23 proposed action is the Approval Action as defined by Administrative Code, Chapter 31; and

1           WHEREAS, Pursuant to Charter, Section 8A.108, all fare changes must be submitted  
2 to the Board of Supervisors as part of the SFMTA's budget or as a budget amendment; now,  
3 therefore, be it

4           MOVED, That the Board of Supervisors supports the SFMTA's amendment to the  
5 Transit Fare and Paratransit Fare Table to provide Free Muni service to low and moderate  
6 income 19 to 22 year-old SFUSD students enrolled in the SFUSD's Special Education  
7 Services Program for FY2015-2016.
