6 WHEREAS, Pursuant to Charter, Section 3.100(18), the Mayor submitted a
7 communication notifying the Board of Supervisors of the reappointment of Wendy Paskin-
8 Jordan to the Retirement Board, received by the Clerk of the Board on December 8, 2014;
9 and

10 WHEREAS, Under Charter, Section 3.100(18), the Board of Supervisors has the
11 authority to reject the reappointment by a two-thirds vote (eight votes) within thirty days
12 following transmittal of the Mayor’s Notice of Reappointment, and the failure of the Board to
13 reject the reappointment by two-thirds vote within the thirty day time period shall result in the
14 reappointee continuing to serve as reappointed; and

15 WHEREAS, The Board of Supervisors, by Motion No. 01-34, established a process to
16 review the Mayor’s reappointment to the Retirement Board; now, therefore, be it

17 **MOVED, That the Board of Supervisors hereby approves the Mayor’s reappointment of**
18 **Wendy Paskin-Jordan to the Retirement Board, seat 4, for a four-year term ending February**
19 **20, 2019.**
