14 disability arising from that service, in accordance with the definitions applied in such cases by  
15 the Veterans' Administration, for the unexpired portion of a four-year term ending January 31,  
16 2019.

17 Stephen Noetzel, seat 8, succeeding himself, term expired, must be an at-large  
18 appointment, for the unexpired portion of a four-year term ending January 31, 2019.

19 Regalado Baldonado, seat 11, succeeding himself, term expired, must be an at-large  
20 appointment, for the unexpired portion of a four-year term ending January 31, 2019.
