17 Mark Watts, seat 5, succeeding himself, term expired, must have a minimum of five
18 years professional experience in the State of California as one of the following: certified public
19 accountant or public accountant; licensed real estate broker; attorney; or a property appraiser
20 accredited by a nationally recognized professional organization, certified by the Office of Real
21 Estate Appraisers, or certified by the State Board of Equalization, for the unexpired portion of
22 a three-year term ending September 3, 2018.

23 Scott Spertzel, seat 6 (Alternate Member), succeeding himself, term expired, must
24 have a minimum of five years professional experience in the State of California as one of the
25 following: certified public accountant or public accountant; licensed real estate broker;

1 attorney; or a property appraiser accredited by a nationally recognized professional
2 organization, certified by the Office of Real Estate Appraisers, or certified by the State Board
3 of Equalization, for the unexpired portion of a three-year term ending September 3, 2018.
