17 Daniel Hershkowitz, seat 5, succeeding himself, term expired, must have a minimum of
18 five years professional experience in the State of California as one of the following: certified
19 public accountant or public accountant; licensed real estate broker; attorney; or a property
20 appraiser accredited by a nationally recognized professional organization, certified by the
21 Office of Real Estate Appraisers, or certified by the State Board of Equalization, for the
22 unexpired portion of a three-year term ending September 3, 2018.

23 Joyce Lewis, seat 6 (Alternate Member), succeeding herself, term expired, must have a
24 minimum of five years professional experience in the State of California as one of the
25 following: certified public accountant or public accountant; licensed real estate broker;

1 attorney; or a property appraiser accredited by a nationally recognized professional
2 organization, certified by the Office of Real Estate Appraisers, or certified by the State Board
3 of Equalization, for the unexpired portion of a three-year term ending September 3, 2018.

4 Angela Cheung, seat 7 (Alternate Member), succeeding Diana Daniel, term expired,
5 must have a minimum of five years professional experience in the State of California as one of
6 the following: certified public accountant or public accountant; licensed real estate broker;
7 attorney; or a property appraiser accredited by a nationally recognized professional
8 organization, certified by the Office of Real Estate Appraisers, or certified by the State Board
9 of Equalization, for the unexpired portion of a three-year term ending September 3, 2018.
