2 COSTS OF INDIGENT DEFENSE IN ADULT CRIMINAL AND JUVENILE DELINQUENCY CASES
3 FOR THE TRIAL COURT FOR FISCAL YEAR 1999-2000, PROVIDING FOR RATIFICATION OF
4 ACTION PREVIOUSLY TAKEN, PLACING \$254,000 ON RESERVE.


