

1 [Year 2000 Annual Joint Fundraising Drive Application Deadlines]  
2 AMENDING SECTION 16.93-4 OF THE SAN FRANCISCO ADMINISTRATIVE CODE,  
3 WHICH ESTABLISHES MARCH 1 OF EACH YEAR AS THE DEADLINE FOR AGENCIES  
4 WHO WISH TO PARTICIPATE IN THE ANNUAL JOINT FUNDRAISING DRIVE TO SUBMIT  
5 THEIR APPLICATIONS, TO ALLOW ANY MAYOR'S FUND TO SUBMIT BY APRIL 15, 2000,  
6 THEIR APPLICATION TO PARTICIPATE IN THE 2000 ANNUAL DRIVE.

10 Be it ordained by the People of the City and County of San Francisco:

11 Section 1. Article V of Chapter 16 of the San Francisco Administrative Code is hereby  
12 amended by amending Section 16.93-4, to read as follows:

13 SEC. 16.93-4. SCHEDULE OF THE ANNUAL DRIVE.

14 (a) By March 1st of each year agencies that wish to participate in the upcoming Annual  
15 Drive shall submit their applications to participate with the Board of Supervisors. Provided  
16 that only for the 1989 Annual Drive, agencies that wish to participate in the 1989 Annual Drive  
17 shall submit their applications to participate with the Board of Supervisors by May 15, 1989.  
18 Provided that only for the 1995 Annual Drive, agencies that wish to participate in the 1995  
19 Annual Drive shall submit their applications to participate with the Board of Supervisors by  
20 May 1, 1995. Provided that only for the 1997 Annual Drive, any Mayor's fund that wishes to  
21 participate in the 1997 Annual Drive shall submit their request to participate with the Board of  
22 Supervisors by July 1, 1997. Provided that only for the 2000 Annual Drive, any Mayor's fund  
23 that wishes to participate in the 2000 Annual Drive shall submit their request to participate  
24 with the Board of Supervisors by April 15, 2000. By March 1st the Mayor shall also designate  
25 the Chair for the upcoming Annual Drive. Provided that only for the 1989 Annual Drive, the

1 Mayor shall designate the Chair for the 1989 Annual Drive by May 15, 1989. Provided that  
2 only for the 1995 Annual Drive, the Mayor shall designate the Chair for the 1995 Annual Drive  
3 by May 1, 1995.


4 (b) By March 1st of each year the Chair of the preceding Annual Drive shall report to  
5 the Mayor and the Board of Supervisors on the success of the concluded Annual Drive  
6 including the level of employee designations to each federated agency. Provided that only for  
7 1989, the Chair of the preceding Annual Drive shall file the report to the Mayor and the Board  
8 of Supervisors as required by this Section by May 15, 1989. Provided that only for 1995, the  
9 Chair of the preceding Annual Drive shall file the report to the Mayor and the Board of  
10 Supervisors as required by this Section by May 1, 1995.

11 (c) By May 1st of each year, the Board of Supervisors, by resolution, shall designate  
12 those agencies that qualify to participate in the City's Annual Drive for that year. Provided that  
13 only for the 1989 Annual Drive, the Board of Supervisors shall designate those agencies that  
14 qualify to participate in the 1989 Annual Drive by June 15, 1989. Provided that only for the  
15 1995 Annual Drive, the Board of Supervisors shall designate those agencies that qualify to  
16 participate in the 1995 Annual Drive by June 1, 1995. Provided that only for the 1997 Annual  
17 Drive, the Board of Supervisors shall designate those Mayor's funds that shall participate in  
18 the 1997 Annual Drive by July 1, 1997.




