

1 [Fee Reduction During Suspension Period]  
2 AMENDING ARTICLE 3 OF PART III OF THE SAN FRANCISCO MUNICIPAL CODE, BY  
3 AMENDING SECTION 253, REDUCING THE FEES PAYABLE BY TRANSIENT  
4 MERCHANTS DURING THE SUSPENSION PERIOD.

6 Be it ordained by the People of the City and County of San Francisco:

7 Section 1. Article 3 of Part III of the San Francisco Municipal Code is hereby amended  
8 by amending Section 253, to read as follows:

9 **SEC. 253. LICENSE FEES.** (a) Except as provided in paragraph (b) below, ((L))  
10 licenses under this Article shall be issued on a quarterly basis and the licensee shall pay a  
11 minimum quarterly fee of \$500 at the time the license is applied for and before it is issued and  
12 thereafter, and in addition thereto, a fee based on gross sales, which shall be at the rate of 10  
13 percent of the gross receipts in excess of \$5,000 from sales made during the quarter.

14 (b) During the suspension period, as defined in paragraph (c) of Section 258 of this  
15 Article, the licensee shall pay a flat quarterly fee of \$150 at the time the license is applied for  
16 and, thereafter, shall not be required to pay the fee based on gross sales described in  
17 paragraph (a) above.


