CREATING UNDERGROUND DISTRICT NO. 356 IN THE STILLMAN STREET AREA.

Note: This entire section is new.

Be it ordained by the people of the City and County of San Francisco:

Section 1. In accordance with the provisions of Section 901, et seq. of Article 18, Chapter X, Part II of the San Francisco Municipal Code (Public Works Code), the Board of Supervisors does hereby create the following underground district:

Underground District No. 356

(Stillman Street District)

covering Stillman Street between Second Street and Third Street.

Section 2. The undergrounding of facilities within this underground district is in the general public interest in that said action will eliminate a heavy concentration of overhead wires on a heavily traveled street.



5 established.






