2 AMENDING ORDINANCE NO. 1061 ENTITLED “REGULATING THE WIDTH OF
3 SIDEWALKS” IN CONNECTION WITH THE MUNI K LINE REPLACEMENT AND THE
4 OCEAN AVENUE STREETScape IMPROVEMENT PROJECT BY ADDING THERETO
5 SECTION 1549 TO CHANGE THE OFFICIAL SIDEWALK WIDTH ALONG PORTIONS OF
6 OCEAN AVENUE BETWEEN JUNIPERO SERRA BOULEVARD AND PHELAN AVENUE;
7 AND MAKING FINDINGS PURSUANT TO THE GENERAL PLAN AND PLANNING CODE
8 SECTION 101.1.

10 Be it ordained by the People of the City and County of San Francisco:


11 Section 1. The Board of Supervisors adopts as its own and incorporates by reference
12 herein as though fully set forth the findings made by the Planning Commission on July 20,
13 2000, in Resolution No. 15927, a copy of which is in the Clerk of the Board of Supervisors’
14 File No. 001535, which stated that the actions contemplated herein are consistent
15 with the General Plan and Eight Priority Policies of Planning Code Section 101.1.

16 Section 2. In accordance with the Department of Public Works’ Order No.172, 515, a
17 copy of which is in the Clerk of the Board of Supervisors’ File No. 001535, Board of
18 Supervisors Ordinance No. 1061, entitled “Regulating the Width of Sidewalks”, a copy of
19 which is in the Clerk of the Board of Supervisors’ File No. 001535, is hereby
20 amended by adding thereto new sections to read as follows:


21 SECTION 1549. In connection with the MUNI K Line replacement and the
22 Ocean Avenue Streetscape Improvement Project, portions of the sidewalk along Ocean
23 Avenue between Junipero Serra Boulevard and Phelan Avenue shall be changed as shown in
24 the Department of Public Works drawings labeled Q-20-516 through Q-20-534, copies of
25 which are in the Clerk of the Board of Supervisors’ File No. 001535.




