1 [Settlement Of Lawsuit]

2 AUTHORIZING SETTLEMENT OF THE LAWSUIT FILED BY CRAIG BANKS
3 AGAINST THE CITY AND COUNTY OF SAN FRANCISCO FOR \$125,000; THE LAWSUIT
4 WAS FILED ON APRIL 3, 1998 IN SAN FRANCISCO SUPERIOR COURT, CASE NO. 994-
5 115; ENTITLED CRAIG BANKS V. CITY AND COUNTY OF SAN FRANCISCO; OTHER
6 MATERIAL TERMS OF SAID SETTLEMENT ARE AS FOLLOWS: (A) THE CITY WILL PAY
7 \$89,258 AS BACK PAY FOR FISCAL YEARS 1997-1998, 1998-1999 AND FOR HALF OF
8 FISCAL YEAR 1999-2000; (B) THE CITY SHALL PAY \$7,742 TO PLAINTIFF AS GENERAL
9 DAMAGES; AND (C) THE CITY WILL PAY \$28,000 IN ATTORNEYS' FEES TO BANKS,
10 HIS ATTORNEY, THOMAS F. DOYLE, AND THE LAW FIRM OF ROSS & LINNEBALL, TO
11 BE HELD IN ESCROW BY THOMAS DOYLE PENDING THE RESOLUTION OF THE
12 ATTORNEYS' FEES LIEN HELD BY ROSS & LINNEBALL.


13 Be it ordained by the People of the City and County of San Francisco:

14 Section 1. The City Attorney is hereby authorized to settle the action entitled "Craig
15 Banks v. City and County of San Francisco, San Francisco Superior Court, Court No. 994-
16 115" by the payment of \$125,000, paid as follows: (a) the City will pay \$97,000, including the
17 amount \$89,258 which represents back pay at the Class 7375 (Apprentice Stationary
18 Engineer) low pay rate for fiscal years 1997-1998 and 1998-1999 and for half of fiscal year
19 1999-2000, and the amount of \$7,742 which is in excess of the two and one-half years back
20 pay at the Class 7375 low pay rate and shall be paid to plaintiff as general damages; (b) the
21 City will pay \$28,000 in attorneys' fees to Banks, his attorney, Thomas F. Doyle, and the law
22 firm of Ross & Linneball. Thomas Doyle shall hold this money in escrow pending the
23 resolution of the attorneys' fees lien held by Ross & Linneball.


1 Section 2. The above-named action was filed in San Francisco Superior Court on April
2 3, 1998, and the following parties were named in the lawsuit: Craig Banks, City and the City
3 and County of San Francisco.



Ordinance authorizing settlement of the lawsuit filed by Craig Banks against the City and County of San Francisco for \$125,000; the lawsuit was filed on April 3, 1998 in San Francisco Superior Court, Case No. 994-115; entitled Craig Banks v. City and County of San Francisco; other material terms of said settlement are as follows: (a) the City will pay \$89,258 as back pay for fiscal years 1997-1998, 1998-1999 and for half of fiscal year 1999-2000; (b) the City shall pay \$7,742 to plaintiff as general damages; and (c) the City will pay \$28,000 in Attorney's fees to Banks, his attorney, Thomas F. Doyle, and the law firm of Ross & Linneball, to be held in escrow by Thomas Doyle pending the resolution of the Attorney's fees lien held by Ross & Linneball.


