
10 Be it ordained by the People of the City and County of San Francisco:

12 Section 1. Chapter 10 of the San Francisco Administrative Code is hereby amended
13 by amending Section 10.46, to read as follows:

14 **SEC. 10.46. ESCHEAT OF FUNDS UNIDENTIFIED FOR TEN YEARS.**

15 All tax collections remaining unidentified for a period of 3 ~~10~~ years shall escheat to the
16 City and County in accordance with the provisions of Sections 50050 to 50053 of Government
17 Code, State of California.


