13 Section 1. Chapter 3 of the San Francisco Administrative Code is hereby amended by
14 adding Section 3.7-1, to read as follows:

15 **SEC. 3.7-1. REPLACING GRANT-FUNDED POSITIONS.**

16 *The Mayor's proposed budget and appropriation ordinance shall include sufficient information*
17 *to identify all positions that were funded by grants during the previous fiscal year, where the grant has*
18 *since expired and the department proposes to fund the position or provide the same services with*
19 *general fund monies for the upcoming fiscal year.*




