Ordinance appropriating \$2,411,887 from the General Fund Reserve to fund salaries, fringe benefits, other current expenses, materials and supplies, and equipment for the Department of Elections for fiscal year 2000-2001; placing funds in the amount of \$800,000 on reserve; placing an additional \$251,000 of previously appropriated Fiscal Year 2000-2001 funds for the Department on reserve; providing for ratification of action previously taken.

Be it ordained by the people of the City and County of San Francisco:

10 **Section 2** Funds in the amount of \$800,000 are hereby placed on reserve, including \$541,570 from  
11 Other Current Expenses, \$187,229 from Materials and Supplies and \$71,201 from  
12 Equipment Purchase, pending the outcome of contract negotiations between the  
13 Department of Elections and Election Systems and Software, Inc., to be released by the  
14 Finance Committee.

14 **Section 3.** Funds in the amount of \$251,000 previously appropriated in the Department of  
15 Elections' Fiscal Year 2000-2001 budget (for Other Current Expenses) for the Election  
16 Systems and Software, Inc., service fee payment are hereby placed on reserve, pending  
17 the outcome of the contract negotiations and potential modifications, to be released  
18 by the Finance Committee.

17 **Section 4.** Although the City has incurred no legal obligation under the Charter, the Board of  
18 Supervisors does hereby appropriate the funds necessary for the obligation and does  
19 hereby ratify the action previously taken.

20 **Section 5.** The Department of Elections is requested to report back to the Finance Committee as  
21 to the results of the final contract negotiations with Election Systems and Software, Inc.,  
22 pertaining to any technological, contract and fiscal impacts regarding this contract.


