9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. The City Attorney is hereby authorized to settle the action entitled "Tayac v.
11 City and County of San Francisco, et al.", United States District Court No. C95-3424 CAL by
12 the payment of \$142,500, other material terms of said settlement are that Tayac shall be
13 barred from future employment with the City and County of San Francisco, and that the
14 Federal District Court Judge shall determine the amount of attorney's fees and costs with a
15 floor of \$60,000 and a ceiling of \$125,000.

16 Section 2. The above-named action was filed in United States District Court on
17 September 26, 1995, and the following parties were named in the lawsuit: Robert Tayac,
18 plaintiff; City and County of San Francisco, Civil Service Commission, San Francisco Police
19 Department, defendants.






