
9 Be it ordained by the People of the City and County of San Francisco:

12 C96-3916 JCS, by the payment of \$95,000.00 as back pay, and that the Federal District Court
13 Judge shall determine the amount of attorney's fees and costs with a floor of \$70,000.00 and
14 a ceiling of \$120,000.00.


