8 Be it ordained by the People of the City and County of San Francisco:

9 Section 1. The City Attorney is hereby authorized to settle the action entitled "Robert
10 Weidman v. City and County of San Francisco, et al.", United States District Court No. C99-
11 4442 TEH by the payment of \$27,500; other material terms of said settlement are that the City
12 and County of San Francisco will pay up to an additional \$20,000 in attorney's fees and costs
13 for necessary work conducted by plaintiffs' counsel after December 10, 2000 to obtain a court
14 ruling approving the settlement and that the San Francisco Police Department will issue a
15 Department Bulletin and otherwise train its officers regarding the proper application of the law
16 at issue.

17 Section 2. The above-named action was filed in United States District Court on May
18 24, 2001, and the following parties were named in the lawsuit: Robert Weidman, plaintiff; City
19 and County of San Francisco, San Francisco Police Department, Officers Constantine Zachos
20 and Officer Carlos Gutierrez.


