3 Ordinance No. 1061 entitled "Regulating the Width of Sidewalks" is amended by  
4 adding thereto Section No. 1551 Changing the Official Sidewalk Width on a Portion  
5 of Front Street between Sacramento and California Streets, as shown on  
6 Department of Public Works drawing labeled Q-20-514 and making findings  
7 pursuant to City Planning Code Section 101.1.

9 Be it ordained by the people of the City and County of San Francisco:

10 SECTION 1: Ordinance No. 1061 entitled "Regulating the Width of Sidewalks", be  
11 and is hereby amended in accordance with the communication filed in the Office of the Clerk  
12 of the Board of Supervisors, by adding thereto a new section to be numbered as follows:

13 Section 1551. The width of sidewalks on a portion of Front Street between  
14 Sacramento and California Streets, shall be as shown on Department of Public Works  
15 drawing labeled Q-20-514, and


16 SECTION 2: The City Planning Department in its letter dated October 11, 2000  
17 stated that the above described change of official sidewalk width is in conformity with the  
18 General Plan, and made findings of consistency with the Eight Priority Policies of Planning  
19 Code Section 101.1.


20 The San Francisco Board of Supervisors adopts as its own and incorporates by  
21 reference herein as though fully set forth the findings made by the City Planning Department  
22 in its letter dated October 11, 2000, that the project intended by the proposed change of  
23 official sidewalk width is consistent with the Eight Priority Policies of City Planning Code  
24 Section 101.1.

2 make arrangements with Public Utility companies and City Departments for the relocation and  
3 / or adjustment of existing utility facilities in the affected sidewalk and street areas.




