ORDINANCE NO. 35-02

1 [Amendments to Conflicts of Interest Code.]

3 **Ordinance amending Article III, Chapter 1 of the San Francisco Campaign and**  
4 **Governmental Conduct Code by adding Sections 3.1-168, 3.1-218, 3.1-423 and 3.1-424,**  
5 **amending Sections 3.1-109, 3.1-110, 3.1-170, 3.1-175, 3.1-215, 3.1-365, 3.1-410 and**  
6 **3.1-435, and repealing Section 3.1-355 to update the list of designated officials who**  
7 **must file financial disclosure statements and to modify the applicable disclosure**  
8 **requirements.**

13 Be it ordained by the People of the City and County of San Francisco:

14 Section 1. The San Francisco Campaign and Governmental Conduct Code is hereby  
15 amended by amending Section 3.1-109 to read as follows:  
16

17 **SEC. 3.1-109. ADMINISTRATIVE SERVICES, DEPARTMENT OF.**

18 (a) **Disclosure Category 2.** Persons in this category shall disclose all  
19 interests in real property.

20 (b) **Disclosure Category 3.** Persons in this category shall disclose all  
21 investments and business positions in business entities, interests in real property, and income  
22 from any source that is subject to the regulatory, permit or licensing authority of the  
23 Department of Administrative Services.

24 (c) **Disclosure Category 4.** Persons in this category shall disclose all  
25 investments and business positions in business entities and income from any source which

1 provides, or contracts with the City and County of San Francisco and its Purchasing  
2 Department to provide commodities or services to the City and County of San Francisco, or  
3 has provided commodities or services to the City and County of San Francisco within the last  
4 two years.

5 (d) **Disclosure Category 5.** Persons in this category shall disclose all  
6 investments and business positions in business entities and income from any source which  
7 provides, or contracts with the City and County of San Francisco to provide, or has provided  
8 within the last two years, commodities or services to either the Division of the Purchasing  
9 Department to which the person is assigned, or the Department (other than the Purchasing  
10 Department), to which the person is assigned.


