11 Be it ordained by the People of the City and County of San Francisco:

12 Section 1. The San Francisco Police Code is hereby amended by amending Section
13 2402, to read as follows:

14
15 **SEC. 2402. COMPENSATION OF ADVISORY COMMITTEE.**

16 Pursuant to the provisions of Section 2 of Proposition "L," the compensation of
17 the appointive members of the Advisory Committee of Street Artists and Craftmen Examiners
18 shall be as follows:

19 (a) A member shall receive \$80 for each meeting of the Advisory Committee
20 actually attended by said member for 50 percent of each meeting of four or more hours.


21 (b) A member shall receive \$80 for each visit to the studio or workshop of an
22 applicant for a Street Artist Certificate for the purpose of viewing the applicant's facilities and
23 verifying that the art or craft item for which the applicant seeks certification is his or her own
24 creation or those of his or her family unit, or for the performance of such other function as
25 shall from time to time be deemed appropriate by the Arts Commission.


