4 **Ordinance amending Section 17.11 (a) of the San Francisco Administrative Code to**  
5 **extend the authorization of the Parking Authority and the Municipal Transportation**  
6 **Agency to utilize a Bid/RFP process for the awarding of all leases and management**  
7 **agreements for the use or operation of parking facilities; the Department shall report to**  
8 **the Board by June 1, 2003, on the development and use of performance measures.**

13 Be it ordained by the People of the City and County of San Francisco:

14 Section 1. Section 17.11 (a) of the San Francisco Administrative Code is hereby amended to  
15 read as follows:

16 SEC.17.11. LEASES AND MANAGEMENT AGREEMENTS FOR PARKING FACILITIES.

17 (a) Except as provided in subsection (c) below, all leases and management  
18 agreements for the use or operation of parking facilities by private persons or entities shall be  
19 awarded through a competitive bid process developed and implemented by the Director of  
20 Property and the ~~Executive Director of the Department of Parking and Traffic;~~ Transportation  
21 or his or her designee in consultation with the Director of Property; provided, however, a  
22 competitive bid process, combined with a request for proposal (“Bid/RFP Process”) which  
23 shall take into consideration qualifications and experience, may be utilized when it is  
24 determined by the ~~Parking and Traffic Commission~~ Municipal Transportation Agency's Board  
25 of Director or Parking Authority that such a process would be in the best interest of the public.



BOARD OF SUPERVISORS

1 In a Bid/RFP Process, the cost to the City for the lease or management agreement for a  
2 parking facility shall constitute not less than sixty percent (60%) of all points granted in the  
3 selection of the successful operator. The authority given to the Parking Authority *and*  
4 *Municipal Transportation Agency* to use this Bid/RFP Process shall sunset on ~~June 1, 2002~~  
5 *June 1, 2007*, unless the Board of Supervisors, by ordinance, continues this authorization.  
6 Prior to such reauthorization by the Board of Supervisors, the Bid/RFP Process shall be  
7 reviewed by the Parking Authority *or Municipal Transportation Agency* to determine if the  
8 utilization of the Bid/RFP Process has been in the best interest of the public, and a report shall  
9 be submitted to the Board of Supervisors.

10 Section 2. The Department shall develop and utilize quantitative, outcome-based  
11 performance measures to aid in the measurement of garage operator performance. The  
12 department will report these measures in writing to the Board by June 1, 2003.


