8 Be it ordained by the People of the City and County of San Francisco:

9 Section 1. The San Francisco Traffic Code is hereby amended by adding Section
10 32.6.34 to read as follows:

11 Sec. 32.6.34. PARKING CONTROL, PORTIONS OF HYDE STREET. No person shall stop,
12 park, or leave standing any vehicle, whether attended or unattended, from 6:00 a.m. to 9:30 a.m. on
13 Wednesdays and Sundays at the following location:

14 Hyde Street, both sides, between McAllister and Fulton Streets except trucks displaying a valid
15 Farmer's Market Truck Parking Permit issued by the Department of Parking and Traffic authorizing
16 parking in said zone.

17 Section 2. Any Farmer's Market Truck displaying a Farmer's Market Truck Parking Permit
18 may be parked on the segment of Hyde Street specified above between 7:00 a.m. and 6:00 p.m. on
19 Wednesdays and Sundays without the deposit of coins in the adjacent parking meters and may park for
20 unlimited periods.
