

[Creating Underground District No. 359 on Octavia Street]

Ordinance Approving Underground District No. 359 On Octavia Street.

Be it ordained by the people of the City and County of San Francisco:

Section 1. In accordance with the provisions of Section 901, et seq. of Article 18, Chapter X, Part II of the San Francisco Municipal Code (Public Works Code), the Board of Supervisors does hereby create the following underground district:

Underground District No. 359

(Octavia Boulevard District)

covering Octavia Street from the northerly line of Market Street to the southerly line of Hayes Street.

Section 2. The undergrounding of facilities within this underground district is in the general public interest in that said action will eliminate a heavy concentration of overhead wires on a major thoroughfare.

Section 3. All work in connection with the undergrounding of facilities lying within this underground district and subject to the laws with reference to underground districts is to be completed in accordance with the Department of Public Works' program; provided, however, that said work shall be commenced at such time or according to such priority as the Department of Public Works has established.


1 Section 4. The Board hereby requests that the utility companies providing the

3 underground service lateral occasioned by the undergrounding.


