15 ~~*(a) There shall be established a Hazardous Materials Advisory Committee (hereinafter*~~
16 ~~*"Advisory Committee") of the City and County of San Francisco.*~~

17 ~~*(b) The Advisory Committee shall consist of 14 members appointed by the Board of*~~
18 ~~*Supervisors. The members shall consist of representatives from each of the following categories:*~~

19 ~~*1 representative from small business;*~~

20 ~~*1 representative from industry;*~~

21 ~~*1 toxicologist;*~~

22 ~~*1 epidemiologist;*~~

23 ~~*1 health educator;*~~

24 ~~*1 representative from neighborhood associations;*~~

25 ~~*2 representatives from environmental organizations;*~~

10 ~~**SEC. 1103.1. ORGANIZATION AND TERMS OF OFFICE.**~~

11 ~~(a) — The term of each member of the Advisory Committee shall be four years.~~

12 ~~(b) — In the event a vacancy occurs during the term of office of any member, a successor shall~~
13 ~~be appointed to complete the unexpired term of the office vacated in a manner similar to that for the~~
14 ~~initial member.~~

15 ~~(c) — At the initial meeting of the Advisory Committee, and yearly thereafter, the Advisory~~
16 ~~Committee members shall select such officers as deemed necessary by the Advisory Committee.~~

17 ~~(d) — The Advisory Committee shall establish rules and regulations for its own organization~~
18 ~~and procedure and shall meet when necessary as determined by the Advisory Committee. All meetings~~
19 ~~shall, except as provided by general law, be open to the public.~~

21 ~~**SEC. 1103.2. POWERS AND DUTIES.**~~

22 ~~The Advisory Committee shall have the power and duty to:~~

23 ~~(a) — Set up subcommittees as necessary;~~

24 ~~(b) — Review and comment on departmental plans and make recommendations to the Director~~
25 ~~of Health and Health Commission, on the following topics:~~

- 1 ~~(1) — Registration and permit process,~~
- 2 ~~(2) — Underground storage,~~
- 3 ~~(3) — Abandoned sites,~~
- 4 ~~(4) — Chemical hazards at home, and~~
- 5 ~~(5) — Outreach to, and education of, the public about hazardous materials;~~
- 6 ~~(c) — Advise the Director of Health on ways to coordinate the actions of the City and County~~
- 7 ~~of San Francisco with all State and federal laws and agencies regulating hazardous materials;~~
- 8 ~~(d) — Monitor, survey and maintain information regarding the number of applications for~~
- 9 ~~hazardous materials certificates of registration and permits to operate a hazardous materials storage~~
- 10 ~~facility not acted upon and the length of time they have been outstanding;~~
- 11 ~~(e) — Submit annual written reports to the Health Commission and to the Board of~~




