9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. The San Francisco Administrative Code is hereby amended by amending  
11 Section 16.703, to read as follows:


12 Sec. 16.703 HEALTH SERVICE SYSTEM; PLAN AND CONTRIBUTION RATES

13 Changes in contribution rates adopted by the Health Service Board, as respects the  
14 plans of the Health Service System, to become effective on ~~July 1, 2002~~ July 1, 2003 for the  
15 fiscal year ~~July 1, 2002~~ July 1, 2003 through ~~June 30, 2003~~ June 30, 2004 approved by the Health  
16 Service Board in actions taken by it on ~~February 14, 2002~~ February 13, 2003 and March 13, 2003,  
17 which plans and contribution rates are on file with the Clerk of the Board of Supervisors, are  
18 hereby approved.

19 Section 2. The Health Service System is requested to submit a written report to the  
20 Board of Supervisors on the Fiscal Year 2002-2003 audited financial statements of the Health  
21 Service System Fund prior to December 2003. This report should contain the Fund balance  
22 and include a summary of claim activity, interest earnings, and surplus contributions which  
23 affect the Fund balance.
