9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. The San Francisco Traffic Code is hereby amended by amending Sections  
11 130 and 131 to read as follows:

12 **SEC. 130. PENALTIES.** ~~*Except as otherwise provided in other provisions of this Chapter*~~  
13 ~~*prescribing penalties for specific offenses, and/or a schedule of penalties for parking violations*~~  
14 ~~*approved by a resolution of the Board of Supervisors as authorized by California Vehicle Code Section*~~  
15 ~~*40203.5, any Pursuant to Section 42001 of the California Vehicle Code, any*~~ person violating any of  
16 the provisions of this Chapter shall be guilty of an infraction and upon conviction thereof shall  
17 be punished for the first offense by a fine not to exceed ~~*\$50*~~ \$100; for the second offense  
18 within a period of one year from the date of the first offense by a fine not to exceed ~~*\$100*~~ \$200;  
19 for a third and each additional offense committed within one year from the date of the first  
20 offense by a fine not to exceed \$250. In addition, except as provided in other provisions of  
21 this Chapter providing authorization for removal of vehicles, any officer of the Police  
22 Department or any Parking Control Officer is hereby authorized to remove or cause to have  
23 removed any vehicle that is parked or left standing unattended in violation of the California  
24 Vehicle Code or the San Francisco Traffic Code and where signs are posted giving notice of  
25 removal for such violation. The procedure for removal and impounding of vehicles shall be as

1 is provided for in Article 9 of the San Francisco Traffic Code and Section 22850 and 22854 of  
2 the California Vehicle Code.

3 **SEC. 131. LATE PAYMENT PENALTIES**

4 (a) The penalty for failure to pay a parking penalty or contest the underlying citation by  
5 the first due date affixed to the notice of parking violation shall be ~~\$12 \$50~~\$25 . The penalty  
6 for failure to pay a parking penalty or contest the underlying citation by the second due date  
7 affixed to the notice of parking violation shall be ~~\$15 \$50~~\$35.

8 (b) By resolution, the Board of Supervisors may waive imposition of these late payment  
9 penalties for any period of time.

10  
11 Section 2. The San Francisco Traffic Code is hereby amended by adding Section 132,  
12 to read as follows:

13 *SEC. 132. PENALTY SCHEDULE. Pursuant to California Vehicle Code Section 40203.5,*  
14 *violation of any of the following subsections of the San Francisco Traffic Code (TC), Police Code(PC)*  
15 *or the California Vehicle Code (VC) shall be punishable by the fines set forth below:*
