13 ~~For Fiscal Year 1999-2000, each~~ Each vendor shall pay a daily fee of ~~\$30~~ \$45 per stall for
14 each day on which he or she sells. A vendor who pays in advance for an entire month shall
15 receive a 10 percent discount on the total charge for that month. ~~After Fiscal Year 1999-2000,~~
16 ~~the Agricultural Commissioner shall propose and the Board of Supervisors shall adopt a new fee~~
17 ~~schedule for the Market.~~




