

1 [Making Environmental Findings and Increasing Street Artist Certificate Fee]

2 **Ordinance making required environmental findings and amending Article 24 of the San**  
3 **Francisco Police Code by amending Section 2404.1 to increase the fee for a Street**  
4 **Artist Certificate and amending Section 2404.2 to clarify the fee setting procedure.**

9 Be it ordained by the People of the City and County of San Francisco:

10 **Section 1. Findings**

11 The Planning Department has determined that the actions contemplated in this  
12 Ordinance are in compliance with the California Environmental Quality Act (California Public  
13 Resources Code sections 21000 et seq.). Said determination is on file with the Clerk of the  
14 Board of Supervisors in File No. 031333 and is incorporated herein by reference.

15 **Section 2.** The San Francisco Police Code is hereby amended by amending Section  
16 2404.1, to read as follows:

17 **Sec. 2404.1. STREET ARTIST CERTIFICATE: FEE.**

18 Pursuant to the provisions of Proposition K, adopted by the voters at an election held  
19 on November 8, 1983, the Board of Supervisors hereby establishes the fee for a Street Artist  
20 Certificate to be as follows: For the period from July 1, 2003 beginning 30 days after enactment  
21 of this ordinance through June 30, 2004, The the fee for a quarterly Street Artist Certificate shall  
22 be ~~\$87.50~~ \$93.40 and said certificate shall be valid for a period of three months from the date  
23 of issuance; except that any person certified as a street artist pursuant to the provisions of this  
24 Article shall have the option of purchasing for ~~\$350~~ \$373.60 an annual certificate valid for a  
25

1 period of one year from the date of issuance. For the period from July 1, 2004 through June 30,  
2 2005, the fee for a quarterly certificate shall be \$99.10 and the fee for an annual certificate shall be  
3 \$396.40. Beginning on July 1, 2005, the fee for a quarterly certificate shall be \$104.80 and the fee for  
4 an annual certificate shall be \$419.20.


5 **Section 3.** The San Francisco Police Code is hereby amended by amending Section  
6 2404.2, to read as follows:

7 **SEC. 2404.2. FEE SETTING PROCEDURE.**

8 Each year the Arts Commission shall cause a report to be made of the revenues  
9 collected for Street Artist Certificates, the costs incurred in administering and enforcing the  
10 provisions of the Street Artist Ordinance (Proposition "L" adopted by the electors of San  
11 Francisco at the election held on November 4, 1975), the anticipated costs for the ensuing  
12 year, and the fee which would be necessary to support such costs. Said report shall be filed  
13 with the Controller no later than April 1st of each year pursuant to the provisions of Section  
14 3.17-2 of the San Francisco Administrative Code. The Controller shall file said report with the  
15 Board of Supervisors no later than May 15th of each year. ~~and the~~ and the Board of  
16 Supervisors shall ~~periodically, by ordinance,~~ by ordinance, establish or readjust the fee for a  
17 Street Artist Certificate ~~by ordinance.~~ The fee set shall be equal to, but not greater than, the  
18 fees necessary to support the costs of administering and enforcing the provisions of the Street  
19 Artist Ordinance.


