3 **Ordinance amending Ordinance No. 1061 entitled "Regulating the Width of**
4 **Sidewalks" by adding thereto Section 1561 to change the official sidewalk**
5 **width on the south side of Market Street west of Third Street; making**
6 **findings pursuant to the General Plan; and requiring relocation,**
7 **modification, or both of facilities affected by the sidewalk width changes.**

9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. The Board of Supervisors adopts as its own and incorporates
11 by reference herein as though fully set forth the findings made by the Planning
12 Department in its letter dated August 7, 2003, which stated that the actions
13 contemplated herein are consistent with the General Plan. A copy of such letter
14 is in the Clerk of the Board of Supervisors File No. 031695.

15 Section 2. In accordance with the Department of Public Works' Order No.
16 174,390, a copy of which is in the Clerk of the Board of Supervisors File No.
17 031695, Board of Supervisors Ordinance No. 1061, entitled "Regulating
18 the Width of Sidewalks," a copy of which is in the Clerk of the Board of
19 Supervisors Book of General Ordinances, in effect May 11, 1910, is hereby
20 amended by adding thereto a new section to read as follows:

21 Section 1561. The width of sidewalks on the south side of Market Street
22 west of Third Street; shall be modified as shown on Department of Public Works
23 drawing Q-20-558, a copy of which is in the Clerk of the Board of Supervisors

Section 3. Millennium Partners, the project sponsor who proposes to undertake the sidewalk construction to implement the sidewalk width changes, is required to make arrangements with public utilities and City Departments concerning relocation, modification, or both of facilities in the affected sidewalk and street areas. Any necessary relocation, modification, or both of such facilities shall be at no cost to the City and County of San Francisco.
