5 **permits issued by the Department of Building Inspection, the Taxi Commission, the**  
6 **Police Department and the Department of Public Works permits where such permits are**  
7 **subject to appeal before the Board of Appeals, revising the surcharge on fees imposed**  
8 **by the Planning Department for review of permits where such permits are subject to**  
9 **appeal before the Board of Appeals, and making environmental findings.**

13 Be it ordained by the People of the City and County of San Francisco:

14 Section 1. Findings

15 The Planning Department has determined that the actions contemplated in this  
16 Ordinance are in compliance with the California Environmental Quality Act (California Public  
17 Resources Code sections 21000 et seq.). Said determination is on file with the Clerk of the  
18 Board of Supervisors in File No. 031747 and is incorporated herein by reference.

19 Sec. 2. The San Francisco Administrative Code is hereby amended by amending  
20 Section 10G.1, to read as follows:

21 **SEC. 10G.1. SURCHARGE IMPOSED; CATEGORIES OF PERMITS AND FEES.**

22 In order to recover the cost to the City and County for the Board of Appeals permit  
23 review functions, at the time a fee for permit application, issuance, or review is collected, a  
24 surcharge in the amount specified shall be charged and collected for the following categories  
25 of permits and fees.

1 (a) For fees imposed by the Department of City Planning pursuant to San Francisco  
2 Planning Code Sections 351(h), 352(a), (except for fees imposed for hearings on Conditional Uses  
3 under Section 303 or Planned Unit Developments under Section 304), 353(a), 353(b), 353(c)  
4 353(d)(3), 353(d)(4), 353(d)(5) or 355 for review of permits that may be appealed to the Board of  
5 Appeals pursuant to Charter Section 4.106, a surcharge of ~~\$5.78~~ ~~9.74~~ 10.00;


6 (b) For permits issued pursuant to San Francisco Building Code Section 110: Tables  
7 1-A, 1-~~GF~~, Item 3, 1-H, 1-K, Item 8, or 1-Q, Item 5 that may be appealed to the Board of  
8 Appeals pursuant to Charter Section 4.106, a surcharge of ~~\$5.78~~ ~~9.74~~ 10.00;

9 (c) For permits issued pursuant to the San Francisco Public Works Code that may be  
10 appealed to the Board of Appeals pursuant to Charter Section 4.106, a surcharge of ~~54~~ ~~82~~  
11 ~~cents~~ ~~(\$0.54~~ ~~82)~~ \$1.00;

12 (d) For permits issued pursuant to San Francisco Police Code Section 2.26 that may  
13 be appealed to the Board of Appeals pursuant to Charter Section 4.106, a surcharge of ~~\$10.47~~  
14 ~~6.94~~ 7.00;

15 (e) For permits issued pursuant to San Francisco Police Code Section 2.26.1 that may  
16 be appealed to the Board of Appeals pursuant to Charter Section 4.106, a surcharge of ~~\$6.76~~  
17 ~~8.78~~ 9.00.




