9 Be it ordained by the People of the City and County of San Francisco:

10 **Section 1. Findings.**

11 The Board of Supervisors hereby finds and declares the following:

12 In the interest of increasing public awareness of the City and County of San  
13 Francisco's cultural resources, historical past, and historic building and district designations,  
14 and to further enhance the experience of tourists visiting the City and County of San  
15 Francisco, the City enacts this section to require that the Department of Parking and Traffic  
16 provide information indicating the name of the designated historic district on all certain street  
17 signs located within any locally designated historic district, as set forth in Article 10 of the San  
18 Francisco Planning Code.


19 Section 2. The San Francisco Traffic Code is hereby amended by adding Section 8, to  
20 read as follows:

21 **Sec. 8. Historic District Street Signs.**

22 The Director of Parking and Traffic shall provide information indicating the designated  
23 historic district on all street signs located within a historic district in the City and County of San  
24 Francisco. This requirement shall apply only to that portion of a street which is located within  
25 the area designed by the City as a historic district. One sign shall be located at each

1 intersection. The Director, or his or her designee, shall, within one year of the ~~effective date~~  
2 of this legislation July 1, 2004, replace existing street signs in historic districts with new street  
3 signs containing the designated historic district information.


