Mission Housing II (San Francisco Co. Super Ct. No. 920940, Court of Appeal No. A085462),



7 1604 or 2635 of the Revenue and Taxation Code.


8 Section 2. The Mission Housing I lawsuit was filed in San Francisco Superior Court on

11 Ltd., Laurel Gardens, St. Francis Square Apartments, Friendship Village Inc., Casa de La
12 Raza, Third Baptist Gardens / F. D. Haynes Apartments, and Glenridge Apartments, as
13 plaintiffs, and the City and County of San Francisco, as defendant. The Mission Housing II
14 lawsuit was filed in San Francisco Superior Court on June 22, 1990 and the following parties
15 were named in the lawsuit: Mission Housing Development Co., Thomas Paine, Ltd., Vista del
16 Monte, Ltd., Buchanan Park, Ltd., Prince Hall Ltd., Laurel Gardens, St. Francis Square
17 Apartments, Friendship Village Inc., Casa de La Raza, Third Baptist Gardens / F. D. Haynes
18 Apartments, and Glenridge Apartments, as plaintiffs, and the City and County of San
19 Francisco, as defendant. The Mission Housing III lawsuit was filed in San Francisco Superior
20 Court on January 26, 1999 and the following parties were named in the lawsuit: Mission
21 Housing Development Co., Thomas Paine, Ltd., Vista del Monte, Ltd., Buchanan Park, Ltd.,
22 Prince Hall Ltd., Laurel Gardens, St. Francis Square Apartments, Friendship Village Inc.,
23 Casa de La Raza, Third Baptist Gardens / F. D. Haynes Apartments, and Glenridge
24 Apartments, as plaintiffs, and the City and County of San Francisco, as defendant. *Mission*
25 *Housing IV* is the collective name for those assessment appeals for which a decision was

1 rendered by the Assessment Assessment Appeals Board on September 9, 2003. The
2 Mission Housing V lawsuit was filed in San Francisco Superior Court on January 30, 2003,
3 and the following parties were named in the lawsuit: Mission Housing Development Co.,
4 Thomas Paine, Ltd., Vista del Monte, Ltd., Buchanan Park, Ltd., Prince Hall Ltd., Laurel
5 Gardens, St. Francis Square Apartments, Friendship Village Inc., Casa de La Raza, Third
6 Baptist Gardens / F. D. Haynes Apartments, and Glenridge Apartments, as plaintiffs, and the
7 City and County of San Francisco, as defendant.




