9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. The San Francisco Administrative Code is hereby amended by amending
11 Section 16.93, to read as follows:

12 **SEC. 16.93. ORGANIZATIONS FOR WHICH DEDUCTIONS CAN BE MADE.**

13 Deductions and collections as provided by this Article shall be made for the
14 organizations and the purposes designated in the following paragraphs:

15 (a) Bona fide unions or employee organizations, for dues or assessments, and for
16 premiums or membership fees for automobile, life, accident, health or disability insurance
17 provided under a group plan by said bona fide unions or employee organizations; and when
18 authorized by memorandum of understanding, voluntary political committee contributions.

19 (b) San Francisco Firemen Federal Credit Union, for the payment of money to or
20 the purchase of shares in.

21 (c) San Francisco Police Department Federal Credit Union, for the payment of
22 money to or the purchase of shares in.

23 (d) Provident Central Credit Union, for the payment of money to or the purchase of
24 shares in.

2 purchase of shares in.

3 (f) San Francisco Federal Credit Union, for the payment of money to or the

12 (k) San Francisco Bay Area Educators' Credit Union, for the payment of money to
13 or the purchase of shares in.

14 (l) San Francisco Civil Service Commission, for fees relating to the imprinting and
15 processing of fingerprints.




