13 Be it ordained by the People of the City and County of San Francisco:

14 Section 1. Findings. The Board of Supervisors of the City and County of San Francisco
15 hereby finds and determines that:

16 (a) Pursuant to Planning Code Section 302, this Board of Supervisors finds that this
17 ordinance will serve the public necessity, convenience and welfare for the reasons set forth in
18 Planning Commission Resolutions No. 16757 and 16758 recommending approval of this
19 Zoning Map Amendment, and incorporates such reasons by this reference thereto. Copies of
20 of said Resolutions are on file with the Clerk of the Board of Supervisors in File No. 040661.

21 (b) Pursuant to Planning Code Section 101.1, this Board of Supervisors finds that this
22 ordinance is consistent with the Priority Policies of Section 101.1(b) of the Planning Code and,
23 when effective, with the General Plan as proposed to be amended, and hereby adopts the
24 findings of the Planning Commission, as set forth in Planning Commission Resolutions No.
25 16757 and 16758, and incorporates said findings by this reference thereto. Copies of said
Resolutions are on file with the Clerk of the Board of Supervisors in File No. 040661.


1 (c) This Board of Supervisors hereby incorporates and adopts its findings under the
2 California Environmental Quality Act regarding the Final Environmental Impact Report for 55
