Be it ordained by the People of the City and County of San Francisco:

Section 1. The San Francisco Campaign and Governmental Conduct Code is hereby amended by amending Section 3.1-215, to read as follows:

**Sec. 3.1-215. ELECTIONS, DEPARTMENT OF.**

Disclosure Category 2. Persons in this category shall disclose all interests in real property, and all investments and business positions in business entities and income from any source which manufactures or sells supplies, materials, machinery or equipment or provides services of the type used by the Department of Elections.

Persons in this category shall disclose all interests in all investments and business positions in business entities and income from any source which manufactures or sells supplies, materials, machinery, equipment or professional services of the type used by the Elections~~
