3 **Ordinance amending San Francisco Administrative Code Sections 8.33.1, 833.2, and**
4 **834.1 to authorize the County Clerk, the Assessor-Recorder, and the Tax Collector to charge fees**
5 **for providing notary services to the public in the amount of \$10 for an Acknowledgment**
6 **and \$10 for a Jurat; and ratifying that requests for marriage certificate index records**
7 **are subject to the same charges as are fictitious business name index records.**

12 Be it ordained by the People of the City and County of San Francisco:

13 Section 1. Findings.

14 The Planning Department has determined that the actions contemplated in this Ordinance are
15 in compliance with the California Environmental Quality Act (California Public Resources Code
16 sections 21000 et seq.). Said determination is on file with the Clerk of the Board of Supervisors in File
17 No. 040505 and is incorporated herein by reference.

18 Section 2. The San Francisco Administrative Code is hereby amended by amending
19 section 8.33.1 as follows:

20 SEC. 8.33.1. COUNTY CLERK'S FEES.

21 (a) Pursuant to Government Code Sections 54985 through 54987 and 26831 and
22 Business and Professions Code Section 22352, the County Clerk is hereby authorized to
23 charge fees to defray the actual cost of issuance of the following documents and the provision
24 of the following services, notwithstanding the fees otherwise set or limited by State law. Any
25 persons requesting the following documents or services shall pay the following fees:

18 Such fees received by the County Clerk shall be deposited with the City and
19 County Treasurer. Portions of the fees for marriage licenses shall be disbursed in accordance
20 with Government Code Sections 26840, 26840.1, 26840.3, 26840.7, and 26840.8 and San
21 Francisco Administrative Code Section 10.117-21.

22 (b) Beginning with fiscal year 2003-2004, fees set in this Section may shall
23 be adjusted each year, without further action by the Board of Supervisors, to reflect changes
24 in the relevant Consumer Price Index, as determined by the Controller. Except, fees charged for
25 notary services provided by the County Clerk shall be adjusted, without further action of the Board of
Supervisors, to reflect changes in Government Code Section 8211, or any subsequent amendment of
that section.

1 No later than April 15th of each year, the County Clerk shall submit its current
2 fee schedule to the Controller, who shall apply the price index adjustment to produce a new
3 fee schedule for the following year.

4 No later than May 15th of each year, the Controller shall file a report with the
5 Board of Supervisors reporting the new fee schedule and certifying that: (a) the fees produce
6 sufficient revenue to support the costs of providing the services for which each fee is
7 assessed, and (b) the fees do not produce revenue which is significantly more than the costs
8 of providing the services for which each fee is assessed.

9 ~~(c) Paragraph (b) shall not apply to fees charged for notary services provided by the~~
10 ~~County Clerk's Office. Any adjustment of such fees shall be governed by Government Code Section~~
11 ~~8211, or any subsequent amendment of that Section.~~

12 Section 3. The San Francisco Administrative Code is hereby amended by amending
13 section 8.33.2 to read as follows:

14 Sec. 833.2. ASSESSOR RECORDER'S FEES.

15 (a) Pursuant to Government Code Sections 54985 through 54987 and 27366, the
16 County Assessor-Recorder is hereby authorized to charge fees to defray the actual cost of
17 issuance of the following documents and the provision of the following services,
18 notwithstanding the fees otherwise set or limited by State law. Any persons requesting the
19 following documents or services shall pay the following fees:

7 (b) Such fees received by the Assessor-Recorder shall be deposited with the City and County

8 Treasurer. Fees charged for notary services provided by the Assessor-Recorder shall be adjusted,
9 without further action of the Board of Supervisors, to reflect changes in Government Code Section
10 8211, or any subsequent amendment of that section.

11 Section 4. The San Francisco Administrative Code is hereby amended by amending
12 section 8.34.1 to read as follows:

13 SEC. 8.34.1. TAX BILLING - ADMINISTRATIVE FEES.

14 (a) Application for Separate Valuation. Pursuant to Section 2821 of the California
15 Revenue and Taxation Code, a fee of \$50 shall be collected by the Tax Collector at the time
16 any person applies to the Tax Collector to have any parcel separately valued on the current
17 roll for the purpose of paying taxes. The fee shall be for the actual costs incurred by the Tax
18 Collector for the processing of an application for separate assessment, and the initial ongoing
19 costs of separate assessment, billings, and mailings. The fee may be billed separately or prior
20 to initial separate tax bills, or both, or collected on subsequent tax bills, and shall be deposited
21 in the General Fund.

22 (b) Delinquent Property Taxes - Installment Payments. Pursuant to Section 4217 of
23 the California Revenue and Taxation Code, persons that request to pay delinquent property
24 taxes in installments shall be subject to a processing fee of \$20. The fee shall be paid to the
25 Tax Collector and may be collected on the tax bill.

1 (c) Preparation and Provision of Documents. Pursuant to Section 162 of the
2 California Revenue and Taxation Code, the Tax Collector shall charge and collect a fee of
3 \$1.00 for preparing each of the following documents:

- 4 (1) A certified copy of a redemption certificate;
5 (2) A certified copy of an installment redemption receipt;
6 (3) A certificate of payment showing taxes paid;
7 (4) A certified copy of an assessment as entered on the assessment role.

8 The fee for providing a copy of any of these records or documents by photographic process
9 shall be the actual cost thereof plus the sum of \$1.00. The fee shall be placed in the General
10 Fund.

11 (d) Notary Fees. Any person requesting notary service shall pay the following fees:

13 Acknowledgment \$10.00

14 Jurat \$10.00

15 (e) Notary fees received by the Tax Collector shall be deposited with the City and County
16 Treasurer. Fees charged for notary services provided by the Tax Collector shall be adjusted, without
17 further action of the Board of Supervisors, to reflect changes in Government Code Section 8211, or any
18 subsequent amendment of that section.


