9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. On March 4, 2002, Mayor Brown established a reward fund of \$10,000 to
11 be paid to any individual or individuals supplying information leading to the arrest and
12 conviction of the person or persons responsible for the death of Mr. Parrish Wingard on July
13 26, 2001. Three John Does came forward and supplied information leading to the arrest and
14 conviction of Juan Stitt for the death of Mr. Wingard. On May 20, 2004, Mr. Stitt pled guilty to
15 voluntary manslaughter with the use of a handgun and was sentenced to eight years in state
16 prison.

17 Section 2. The Controller of the City and County of San Francisco is hereby
18 authorized to draft warrants upon the Treasury of the City and County of San Francisco
19 totalling Ten Thousand Dollars (\$10, 000) to be split among and paid to the three John Does
20 who supplied the information leading to the arrest and conviction of Juan Stitt for the death of
21 Parrish Wingard.




