3 **Ordinance amending Zoning Map Sheets 9 and 9H of the City and County of San**
4 **Francisco to eliminate use districts and height and bulk districts within Assessor's**
5 **Block 4591A, the Hunters Point Redevelopment Plan area, and instead reference the**
6 **Hunters Point Shipyard Redevelopment Plan; and making various findings, including**
7 **environmental findings and findings of consistency with the General Plan and Planning**
8 **Code Section 101.1.**

10 Be it ordained by the People of the City and County of San Francisco:

11 Section 1. Findings. The Board of Supervisors of the City and County of San Francisco
12 hereby finds and determines that:

13 (a) Pursuant to Planning Code Section 302, this Board of Supervisors finds that this
14 ordinance will serve the public necessity, convenience and welfare for the reasons set forth in
15 Planning Commission Resolution No. 16901 recommending approval of this Zoning Map
16 Amendment, and incorporates such reasons by this reference thereto. A copy of said
17 resolution is on file with the Clerk of the Board of Supervisors in File No. 041539.

18 (b) Pursuant to Planning Code Section 101.1, this Board of Supervisors finds that this
19 ordinance is consistent with the Priority Policies of Section 101.1(b) of the Planning Code and,
20 when effective, with the General Plan as proposed to be amended and hereby adopts the
21 findings of the Planning Commission, as set forth in Planning Commission Resolution No.
22 16900, and incorporates said findings by this reference thereto.

23 (c) In accordance with the actions contemplated herein, this Board adopted Resolution
24 No. 751-04, concerning findings pursuant to the California Environmental Quality Act
25 (California Public Resources Code sections 21000 et seq.). A copy of said Resolution is on

1 file with the Clerk of the Board of Supervisors in File No. 041533 and is incorporated
2 herein by reference.

4 Section 2. Pursuant to Sections 235 and 302(c) of the Planning Code, the following
5 amendments to the Zoning Map, duly approved by resolution of the Planning Commission, are
6 hereby adopted as an amendment to Zoning Map Sheets 9 and 9H of the City and County of
7 San Francisco, a copy of which is on file with the Clerk of the Board of Supervisors in File No.
8 041539.


