3 **Ordinance amending Ordinance No. 1061 entitled “Regulating the Width of Sidewalks”**  
4 **by adding thereto Section No. 1565 to change the official sidewalk widths on the**  
5 **easterly side of Waverly Place; making environmental findings and findings pursuant**  
6 **to the General Plan and Planning Code Section 101.1; and requiring relocation,**  
7 **modification, or both of facilities affected by the sidewalk widths changes.**

12 Be it ordained by the People of the City and County of San Francisco:

13 Section 1. The Board of Supervisors adopts as its own and incorporates by reference  
14 herein as though fully set forth the findings made by the Planning Department in its letter  
15 dated December 14, 2004, which stated that this project is in conformity with the San  
16 Francisco General Plan and the priority policies of Planning Code Section 101.1. Said letter  
17 also contains a determination that the actions contemplated in this Ordinance are in  
18 compliance with the California Environmental Quality Act (California Public Resources Code  
19 sections 21000 et seq.). A copy of said letter is in the Clerk of the Board of Supervisors File  
20 No. \_\_\_\_\_ and is incorporated herein by reference.

21 Section 2. In accordance with the Department of Public Works Order No. 175,174, a  
22 copy of which is in the Clerk of the Board of Supervisors File No. 050187, Board of  
23 Supervisors Ordinance No. 1061, entitled “Regulating the Width of Sidewalks,” a copy of  
24 which is in the Clerk of the Board of Supervisors Book of General Ordinances, in effect May  
25 11, 1910, is hereby amended by adding thereto a new section to read as follows:

1           Section 1565. The official sidewalk widths on the easterly side of Waverly Place shall be as  
2 shown on Department of Public Works drawings Q-20-625 and Q-20-626, copies of which are in the  
3 Clerk of the Board of Supervisors File No. 050187.

4           Section 3. The Department of Public Works, as is necessary as a result of this  
5 Ordinance, shall make arrangements with public utility companies and City Departments for  
6 the relocation, modification, or both of existing utility facilities in the affected sidewalk and  
7 street areas. Any necessary relocation, modification, or both of non-City facilities shall be at  
8 the cost to the City and County of San Francisco.




