7 Be it ordained by the People of the City and County of San Francisco:

8 Section 1. The City Attorney is hereby authorized to settle the action entitled Klara
9 Khaimskaya, et al., v. City and County of San Francisco, et al., San Francisco Superior Court,
10 Court No. 425-488. Consistent with this settlement the City Attorney is hereby authorized to
11 make a payment of \$1,020,000 from the General Fund in addition to the payment of
12 \$1,020,000 approved by the Municipal Transportation Agency Board of Directors for a total
13 settlement amount of \$2,040,000.

14 Section 2. The above-named action was filed in San Francisco Superior on
15 October 16, 2003, and the following parties were named in the lawsuit: Klara Khaimskaya
16 and Issak Khaimsky, plaintiffs and City and County of San Francisco, defendant.


