8 Be it ordained by the People of the City and County of San Francisco:

9 Section 1. The San Francisco Police Code is hereby amended by repealing Section
10 1183.2 in its entirety:

11 **~~SEC. 1183.2. RESTRICTED AREAS.~~**


13 ~~*Commencing at the point of intersection of the northerly line of Sutter Street with the westerly*~~
14 ~~*line of Mason Street; thence easterly along the northerly line of Sutter Street to its intersection with the*~~
15 ~~*westerly line of Grant Avenue; thence northerly along the westerly line of Grant Avenue to its*~~
16 ~~*intersection with the northerly line of Bush Street; thence easterly along the northerly line of Bush*~~
17 ~~*Street to its intersection with the westerly line of Kearny Street; thence northerly along the westerly line*~~
18 ~~*of Kearny Street to its intersection with the northerly line of California Street; thence easterly along the*~~
19 ~~*northerly line of California Street to its intersection with the northerly line of Market Street; thence*~~
20 ~~*southerly across Market Street to the intersection of the southerly line of Market Street with the easterly*~~
21 ~~*line of Spear Street; thence westerly along the southerly line of Market Street to its intersection with the*~~
22 ~~*westerly line of Fifth Street; thence northerly across Market Street to the northerly line of Market*~~
23 ~~*Street; thence westerly along the northerly line of Market Street to its intersection with the westerly line*~~
24 ~~*of Mason Street; thence northerly along the westerly limit Mason Street to the point of commencement;*~~
25 ~~*provided, however, that for the purpose of encouraging the use of mass transit facilities, the Board of*~~

1 ~~Supervisors, by resolution, may designate specific routes within the area described hereinabove along~~
2 ~~which the aforesaid vehicles may be operated.~~

3 ~~The provisions of this Section shall not apply to any "sightseeing bus" as defined in Section~~
4 ~~1155 of this Code used for the transporting of tourists and sightseers, over the public streets between~~
5 ~~certain defined points of termini within the limits of the City and County of San Francisco.~~




