9 Be it ordained by the People of the City and County of San Francisco:

10 **Section 1. Making Environmental Findings.** The Planning Department has  
11 determined that the actions contemplated in this Ordinance are in compliance with the  
12 California Environmental Quality Act (California Public Resource Code sections 21000 et  
13 seq.). Said determination is on file with the Clerk of the Board of Supervisors in File No. and  
14 is incorporated herein by reference.

15 Section 2. The San Francisco Park Code is hereby amended by repealing Section  
16 12.11:

6 Section 3. The San Francisco Park Code is hereby amended by adding Section 12.11,  
7 to read as follows:

8 **Sec. 12.11 MARINA FEES.**

9 The following fees shall be charged for goods and services at the San Francisco Marina Small  
10 Craft Harbor:

11 (a) Berth Rental Fees. The charges shall be based on the overall length of the entire  
12 vessel or the length of the berth, which ever is greater.

4                    (j) Adjustment of Fees. The berth rental and guest dock fees for the West Harbor shall be  
5 increased, without further action of the Board of Supervisors, for Fiscal Year 2006-2007 by twenty  
6 percent (20%), and for Fiscal Years 2007-2008, 2008-2009, 2009-2010, by four percent (4%) per year.  
7 Thereafter the berth rental and guest dock fees shall be adjusted in accordance with Section 12.20 of  
8 this Article.

9                    The berth rental and guest dock fees for the East Harbor shall be increased, without further  
10 action of the Board of Supervisors, for Fiscal Years 2006-2007, 2007-2008, 2008-2009 by twelve  
11 percent (12%). Thereafter the berth rental and guest dock fees shall be adjusted in accordance with  
12 Section 12.20 of this Article.


