10 Be it ordained by the People of the City and County of San Francisco:

12 Section 1. The San Francisco Administrative Code is hereby amended by amending
13 Section 10.100-28 to read as follows:

14 **SEC. 10.100-28. ART COMMISSION MARKET STREET ART MAINTENANCE FUND**

15 **ACCOUNT.**

16 (a) **Establishment of Fund Account.** The Art Commission Market Street Art
17 Maintenance Fund Account is established as a separate account within the Arts Commission Public
18 Arts Fund under Section 10.100-30 of the San Francisco Administrative Code, a category four fund,
19 to receive the City and County's share of advertising revenues from transit shelter advertising
20 on Market Street, as provided in the Advertising Transit Shelter Agreement, as amended.
21 Additionally, any monies appropriated by the Board of Supervisors for maintenance of art on
22 Market Street shall be deposited in this fund account.

23 (b) **Use of the Fund Account.** The fund monies in this account shall be ~~used~~ expended
24 exclusively for the maintenance and restoration of public art on Market Street.

2 Section 2. The San Francisco Administrative Code is hereby amended by amending
3 Section 10.100-30 to read as follows:

4 **SEC. 10.100-30. ART COMMISSION PUBLIC ARTS FUND.**

5 (a) **Establishment of Fund.** The Art Commission Public Arts Fund is established as a
6 category ~~six~~ four fund to receive all revenue from programs, events, and sale or use of works
7 of art which are under the supervision and control of the Art Commission as well as monies
8 collected and deposited under the Arts Commission Market Street Art Maintenance Account and Arts
9 Commission Youth Arts Account in accordance with Administrative Code Sections 10.100-28 and
10 10.100-34.

11 (b) **Use of Fund.** Unless otherwise provided by Charter, municipal code, contract or funding
12 source, the ~~The monies in said fund are for expenditure exclusively~~ shall be expended only for the
13 purpose of conducting arts programs and events, the character and nature of which shall be
14 determined by the Art Commission. Any revenue collected from the sale, exchange, or
15 exhibition of a work of art under the jurisdiction of the Art Commission shall be expended
16 exclusively for the purpose of acquiring or maintaining works of art for the same public
17 structure or purpose for which the original work of art was acquired.

18 (c) **Exceptions to Fund Category.** The Art Commission shall authorize all
19 expenditures from the fund. ~~Any unexpended balance available at the end of any fiscal year in excess~~
20 ~~of \$500,000 shall, subject to the review of the Controller, be placed in the General Fund.~~

21 ~~(d) Administration of Fund. The Art Commission shall, on or before February 1, 1983, and~~
22 ~~thereafter on or before February 1st, annually, submit in writing to the Board of Supervisors and to its~~
23 ~~Finance Committee, a report showing the total revenue credited to said special fund to and including~~

1 *the date of said report and a description of the programs and events for which the revenue credited to*
2 *said special fund is to be expended.*

4 Section 3. The San Francisco Administrative Code is hereby amended by amending
5 Section 10.100-34 to read as follows:

6 **SEC. 10.100-34. ART COMMISSION YOUTH ARTS FUND ACCOUNT.**

7 (a) **Establishment of Fund Account.** The Art Commission Youth Arts Fund ~~Fund~~
8 Account is established as a separate account within the Arts Commission Public Arts Fund under
9 Section 10.100-30 of the San Francisco Administrative Code, a category four fund, to receive half of
10 the annual payment made to the City under Section II.B of the Advertising Transit Shelter
11 Agreement, as amended, and any monies appropriated by the Board of Supervisors for youth
12 arts programs.

13 (b) **Use of the Fund Account.** The fund monies in this account shall be ~~used~~ expended
14 exclusively for providing programs and opportunities for the talents and creativity of young
15 artists.




