10 Be it ordained by the People of the City and County of San Francisco:

11 Section 1. Findings

12 The Planning Department has determined that the actions contemplated in this  
13 Ordinance are in compliance with the California Environmental Quality Act (California Public  
14 Resources Code section 21000 et seq.). Said determination is on file with the Clerk of the  
15 Board of Supervisors in File No. 051002 and is incorporated herein by reference.

16 Section 2. The San Francisco Administrative Code is hereby amended by adding  
17 Section 2A.22.1, to read as follows:

18 **Sec. 2A.22.1. Mayor's Office on Disability Plan Review and Site Inspection Fees**

19 Any city administered or funded construction project requiring the Mayor's Office on Disability  
20 plan review or site inspection for compliance with Federal disability access laws and regulations shall  
21 pay a fee consistent with this section. For the purpose of this section, "plan review" includes reviewing  
22 and approving architectural drawings, site plans, and construction plans for compliance with Federal  
23 disability access laws and regulations prior to the commencement of work. For the purpose of this  
24 section, "site inspection" includes inspecting and approving all work for compliance with Federal  
25 disability access laws and regulations during the construction phase of the project.

1 (a) Plan Review and Site Inspection Fees. At the time the project sponsor submits its  
2 architectural drawings, site plans, and construction plans to the Mayor's Office on Disability, the  
3 project sponsor shall pay to the Mayor's Office on Disability a fee as set forth below:

<u>Project Size</u>	<u>Fee</u>
<u>\$0 to \$100,000</u>	<u>\$150</u>
<u>\$100,001 to \$1,000,000</u>	<u>.15% (.0015) of the total valuation of the project</u>
<u>\$1,000,001 to \$10,000,000</u>	<u>\$1,600 + .05% (.0005) of the total valuation of the project</u>
<u>\$10,000,001 and up</u>	<u>\$10,000 + .015% (.00015) of the total valuation of the project</u>

9 For the purposes of this section, "total valuation of the project" shall mean the amount as  
10 determined under San Francisco Building Code section 107.2. The Mayor's Office on Disability shall  
11 not be required to review the architectural drawings, site plans, and construction plans or conduct any  
12 site inspections until the project sponsor pays the fee established by this section.

13 (b) Waiver. The Director of the Mayor's Office on Disability may waive the fees  
14 received under this section where the project sponsor demonstrates in a written application that  
15 payment of such fees would present an undue financial hardship on the project sponsor.


