11 Section 1. The San Francisco Administrative Code is hereby amended by adding  
12 Section 10.100-290, to read as follows:

13 **SEC. 10.100-290. SAN FRANCISCO CITY SERVICES PRESERVATION FUND.**

14 (a) Establishment of Fund. The San Francisco City Services Preservation Fund is  
15 established as a category five fund for the purpose of receiving donations from employees and private  
16 donors in order to offset the City's deficit and preserve City services.

17 (b) Use of Fund. All deposits into the fund will be transferred into the General Fund and  
18 expenditures from the Fund shall be subject to the budgetary and fiscal provisions of the Charter.


