8 Be it ordained by the People of the City and County of San Francisco:

9 Section 1. Findings.

10 The Planning Department has determined that the actions contemplated in this
11 Ordinance are in compliance with the California Environmental Quality Act (California Public
12 Resources Code sections 21000 et seq.).

13 Section 2. The San Francisco Park Code is hereby amended by adding Section 12.41.
14 to read as follows:

15 **SEC. 12.41. PROFESSIONAL TENNIS LESSON RATES.**

<u>Lesson Type</u>	<u>Rates</u>
<u>1/2 Hour Private</u>	<u>\$30.00</u>
<u>1 Hour Private</u>	<u>\$50.00</u>
<u>1 Hour – 2 Person</u>	<u>\$30.00 per person</u>
<u>1 Hour – Group (maximum 6 people)</u>	<u>\$20.00 per person</u>
<u>1 Hour – Youth Group (12 years or younger, max. 6 youth)</u>	<u>\$16.00 per person</u>
<u>Cancellation Fee (less than 24 hours notice)</u>	<u>25% of lesson cost</u>




