8 Be it ordained by the People of the City and County of San Francisco:

9 Section 1. Findings.

10 A. The Planning Department has determined that the actions contemplated in this
11 Ordinance are in compliance with the California Environmental Quality Act (California Public
12 Resources Code sections 21000 et seq.). Said determination is on file with the Clerk of the
13 Board of Supervisors in File No. 060782 and is incorporated herein by reference.

14 Section 2. The San Francisco Health Code is hereby amended by amending Section
15 128, to read as follows:

16 Sec. 128 PATIENT RATES. (a) The Board of Supervisors of the City and
17 County of San Francisco does hereby determine and fix the proper reasonable amounts to be
18 charged to persons for services furnished by the Department of Public Health as follows,
19 which rates shall be effective for services delivered as of ~~July 1, 2005~~ July 1, 2006.


