10 Be it ordained by the People of the City and County of San Francisco:

11 Section 1. The San Francisco Traffic Code is hereby amended by amending Sections
12 Sections 64 and 63(A), to read as follows:

13 **SEC. 63. COMMERCIAL VEHICLES; PARKING LIMITED IN CERTAIN USE**
14 **DISTRICTS.**

15 It shall be unlawful for the operator of any motor truck, truck tractor, road tractor, van,
16 trailer, delivery wagon, or any vehicle with a manufacturer's gross vehicle weight rating or a
17 gross combination weight rating in excess of 10,000 pounds and used for commercial purposes,
18 except vehicles of public utilities and construction equipment engaged in repair or
19 construction, to park or leave standing for a period in excess of one hour any such vehicle in
20 any street in an RH-1(D), RH-1, RH-2, RH-3, RM-1, RM-2, RM-3, RM-4 or P Use District,
21 except while in the course of delivery or removal of goods, merchandise or other personal
22 property for residents on such street or except when such vehicle is used by a recreational
23 equipment vendor as defined in Section 1050 of the Police Code in the course of his business
24 and all the requirements of Police Code Sections 1051, 1052, 1053, 1054 and 1055 are met.

1 Any excepted vehicle shall be subject to all parking limitations applicable thereto as otherwise
2 provided by law.

3 **SEC. 63(A). COMMERCIAL VEHICLES; PARKING PROHIBITED IN CERTAIN USE**
4 **DISTRICTS BETWEEN 2:00 A.M. AND 6:00 A.M.**

5 It shall be unlawful for the operator of any motor truck, truck tractor, road tractor, trailer,
6 delivery wagon or any vehicle with a manufacturer's gross vehicle weight rating or a gross
7 combination weight rating of over 10,000 pounds and used for commercial purposes to park or
8 leave standing any such vehicle in any street in an RH-1(D), RH-1, RH-2, RH-3, RM-1, RM-2,
9 RM-3, RM-4 or P Use District between the hours of 2:00 a.m. and 6:00 a.m. This provision
10 shall not apply to vehicles of public utilities and construction equipment engaged in repair or
11 construction work at or near the location at which the vehicle is parked.




