13 Be it ordained by the People of the City and County of San Francisco:

14 Section 1. The San Francisco Administrative Code is hereby amended by adding
15 Section 2A.87, to read as follows:

16 Sec. 2A.87 PRESS ROOM TELEPHONES.

17 It shall be the policy of the City and County of San Francisco that the Police
18 Department neither inspect nor make use of records of City telephones provided for the use of
19 members of the news media in the Press Room at the Hall of Justice, except as authorized by
20 search warrant or subpoena issued pursuant to local, state or federal law. Therefore, the City
21 may not expend monies appropriated to the Police Department to fund the cost of providing
22 these telephones. To the extent that the City incurs such costs, payment shall be drawn from
23 the budget of the Department of Administrative Services.


